### New Features for 2017

- Added the ability to globally reset invalid/missing SINS to 000-000-000
- Added the ability to enter/import T4 and Relève 1 slip data independently of each other
- Enhanced the importing of T3 returns so that trust setup data can be imported alongside recipient data
- T5013FIN XML files can now be prepared and submitted to CRA
- Enhanced error checking reduces the occurrence of invalid Revenu Québec XML files by as much as 90%

**eForms Standard** adds powerful features to the Basic version to make processing information returns more efficient for larger firms:

- **Multi-user networking capabilities:** Gives an unlimited number of users concurrent access to data files stored on a network and keeps track of each user's setup options and settings.
- **Import from Excel:** Import data from Excel spreadsheets, eliminating the need to re-enter data that is available from other sources.
- **Import from XML:** Import slip data from any 2015 or 2016 electronic submission file, regardless of source.
- **Batch electronic filing:** Submit government copies of slips and summaries for multiple return types and companies in a single electronic submission (XML) file.
- **Federal and Québec partnership forms:** Includes slips, summaries, 13 federal schedules and 6 Québec schedules, fully integrated to link data to the correct forms.

**eForms Enterprise** is designed for organizations with high volumes and special requirements. Based on eForms Standard, eForms Enterprise adds the following features, allowing it to meet the needs of the largest organizations:

- The Event Viewer enables system administrators to view the history of data entry, printing, e-filing and other activity. Activities are tracked by date and time, user, company and type of activity.
- Distribute password protected PDF slips to recipients with eForms' built-in email capability.
- Enhanced filing status management enables system administrators to view filing status details for any company

or group of companies.

- Prepare Federal T3 slips, returns and summaries plus Québec RL-16 slips and TP-646 returns.
- Print slips filtering: Select slips to be printed by contents of any data field.

**eForms Lite** gives you the ability to paper or Internet file T4, T4A, T5, RL-1 and RL-3 returns with 25 slips in each return for up to five companies.
